COMPARISON OF PORTFOLIO INVESTMENT EARNINGS TO THE FY 2006-07 BUDGET

Below is a comparison of actual investment earnings on an accrual basis to the fiscal year 2006-07 budget. Monthly budgeted earnings apportionments for the City funds are based upon historical cash balance averages. As reported in the Notes to the General Purpose Financial Statements in the City's Comprehensive Annual Financial Report (CAFR), annual budgets are not prepared for some funds (for example, Nonexpendable Trust Funds, Repair and Demolition Fund, etc). The City's budgets for the General Fund, Special Funds and Capital Improvement Programs reflect annualized investment income earnings of \$17.7 million. The following schedule reflects the investment earnings of only the budgeted City funds participating in investment portfolio fund 1.

The Redevelopment Agency projects annualized investment income earnings of \$4.0 million for Fiscal Year 2006-07. Of this, \$1.4 million is investment income earnings from the Agency's participation in the City's investment program. The \$2.6 million balance of the projected interest earnings comes from funds in various escrow accounts that were transferred out from the City's investment program and deposited to a local bank by the Agency in compliance with the Disposition and Development Agreements. The amounts shown for the Redevelopment Agency's monthly and fiscal year-to-date budgeted investment earnings are based on the Agency's annual budget for its participation in the City's investment program, apportioned on a pro-rata basis for the month and year-to-date, respectively.

INVESTMENT STRATEGY

Due to the uncertainty of economic growth and direction of interest rates, investors continued to maintain a shorter investment horizon as the yield curve remained inverted (market yields in the mid to long range were lower than shorter term investments). Under these market conditions, we continued our investment strategy to invest in the 12-to-24 month horizon to help mitigate market risk, while expanding the weighted average days to maturity. During August, opportunities to expand the weighted average days to maturity were limited as the City and the Redevelopment Agency covered its cash requirements. In addition to payroll and accounts payable, disbursements included transfers to the trustees for debt service payments which primarily contributed to the net decrease of \$62 million in portfolio size as of August 31, 2006 compared to the amount reported as of July 31, 2006.

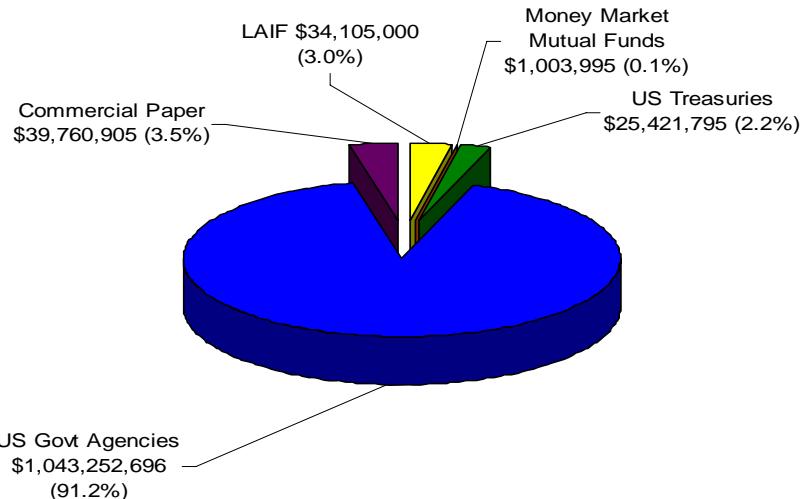

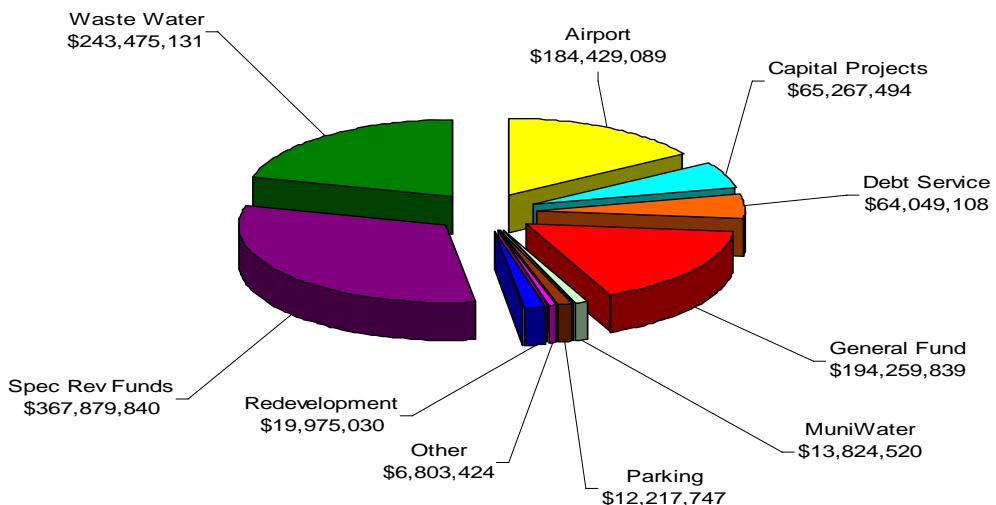

as of August 31, 2006



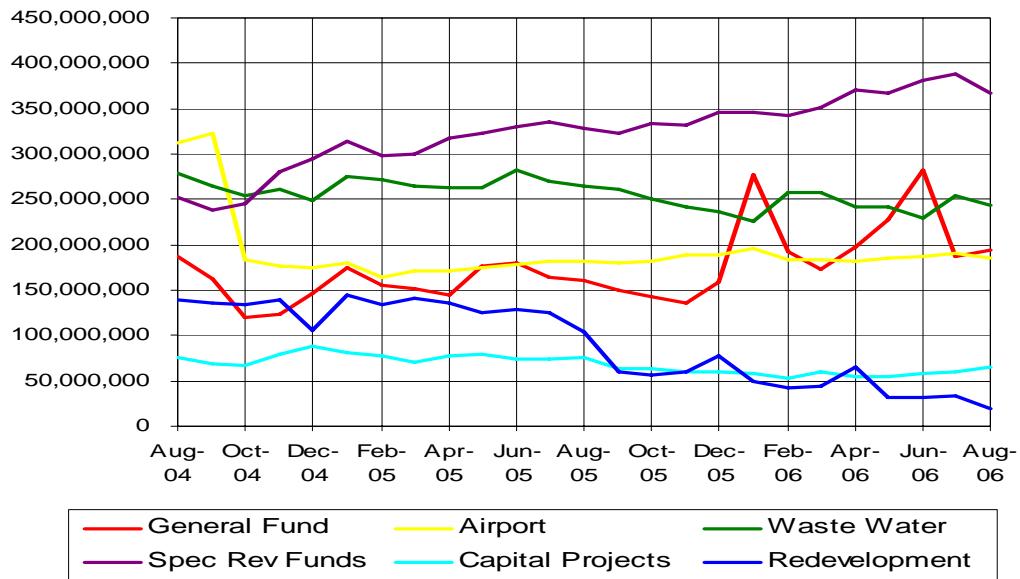

Monthly Comparison of Balances by Fund Type

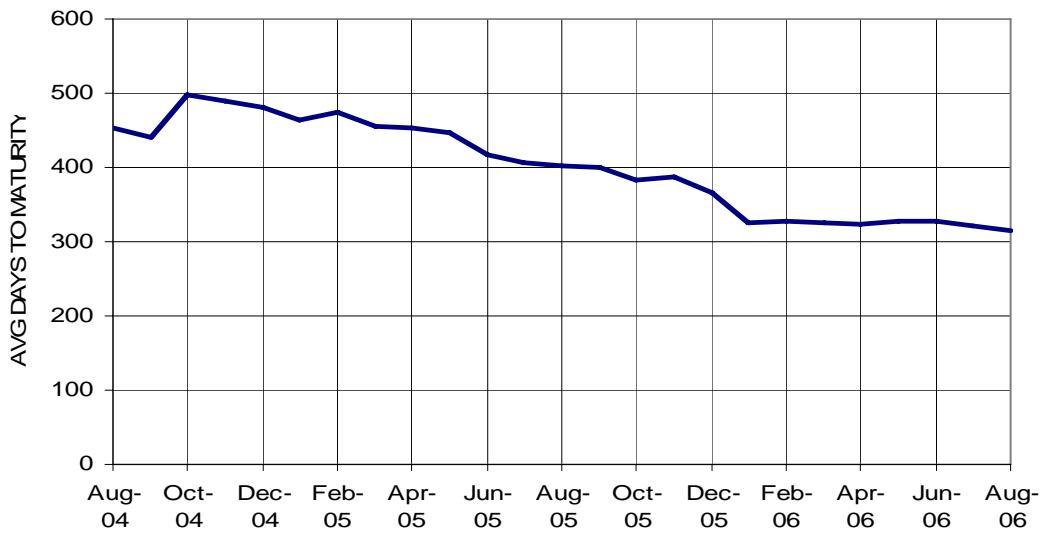
August 2004 through August 2006

Maturity Trend

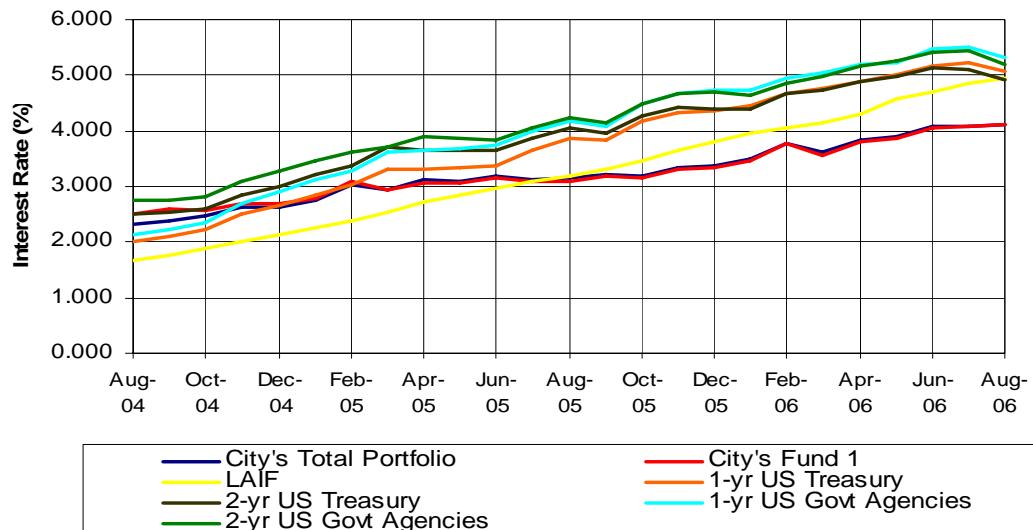
August 2004 through August 2006
